

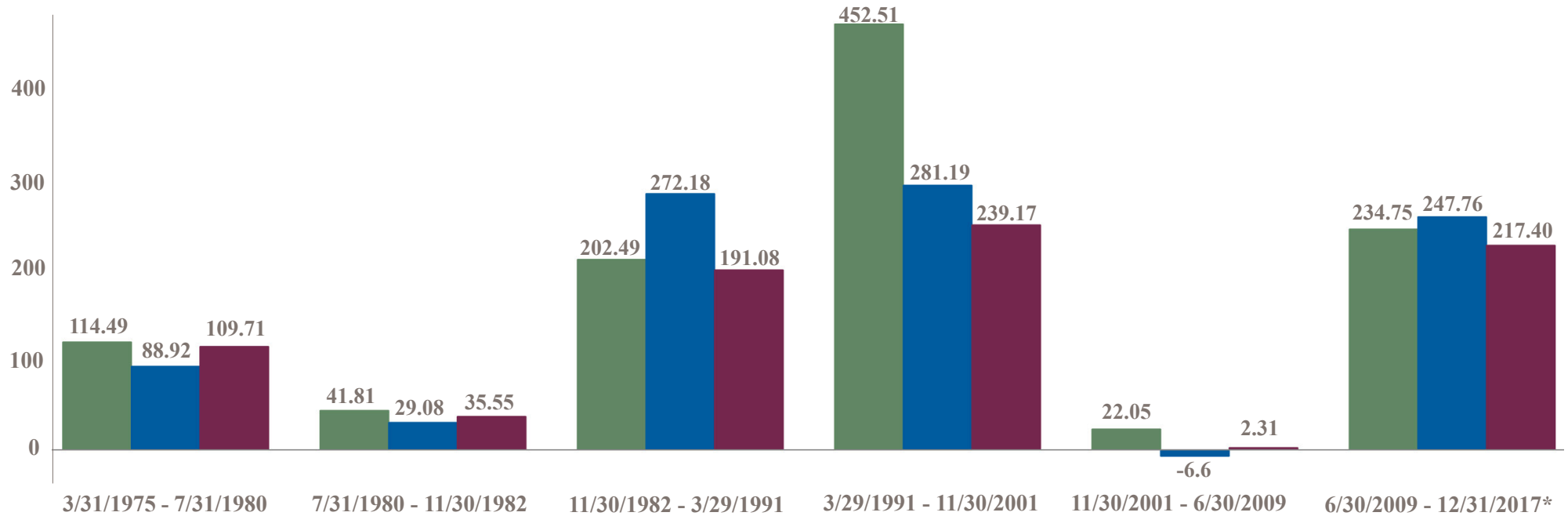

## Explanation of Time Periods Selected

When Mairs & Power talk about the advantages of holding through a “economic cycle”, the cycle that is most relevant is the economic business cycle fluctuating between expansion and contraction. For this chart, the National Bureau of Economic Research (NBER) recessionary periods in the U.S. economy was used. The NBER defines a recession as a significant decline in economic activity spread across the economy, lasting more than a few months, normally visible in real GDP, real income, employment, industrial production and wholesale-retail sales. The NBER also calls recessionary beginning and ending points, peaks and troughs by month. In the chart, trough to trough points in time is shown.
